## **Indigent Defense Updates**

### AB 2483: Procedural Guidelines for Postconviction / Resentencing Hearings

On January 1, 2025, AB 2483 became law, creating an affirmative duty for the presiding judge of each county to meet with public defenders and other stakeholders to develop a plan for post-conviction / resentencing cases. It also creates additional procedural requirements, establishes new timelines for processing time-sensitive release orders, and clarifies CDCR's responsibility to provide relevant records. To help stakeholders navigate these changes, OSPD-IDID has developed a two-page informational sheet outlining the new law and the practical implications for post-conviction/resentencing proceedings.
